**Job Summary:** This position performs all aspects of construction and maintenance of outside plant buried cable facilities.

  - work completely and accurately under time constraints and deadlines.
  - obtain and maintain a valid Montana Commercial Driver's (CDL) license, Type I, Class A, with airbrake endorsement., as well as have a good driving record and be insured under the Company insurance policy.
  - read cable records, staking sheets, specifications, and circuit diagrams.
